## Export Control Act 2020

## APPOINTMENT OF AUTHORISED OFFICERS

I, **DAVID IRONSIDE**, delegate of the Secretary of the Department of Agriculture, Water and the Environment and acting pursuant to subsection 291(7) of the *Export Control Act 2020* (the Act), **APPOINT RAGHU PAL REDDY NERAVETLA (PE60430)** (Authorised Officer) as an authorised officer under the Act to perform the job functions specified in Schedule 1.

**POWERS AND FUNCTIONS OF THE AUTHORISED OFFICER:** (For the purposes of s 301(1) of the Act): For the purpose of performing each job function identified in Schedule 1, the Authorised Officer can exercise or perform the corresponding powers and functions specified in Schedule 2.

#### **SUBDELEGATION**

I, **DAVID IRONSIDE**, delegate of the Secretary of the Department of Agriculture, Water and the Environment, acting pursuant to paragraph 288(2)(a) of the Act ,

**SUBDELEGATE** the powers and functions specified in Schedule 3 to the Authorised Officer for the purpose of performing each job function identified in Schedule 2.

This instrument commences on the date this instrument is signed and continues until 04 April 2024 (subject to the next paragraph, if relevant).

For the job function of export inspection of bulk vessels only:

The

- a. Authorised Officer's authorisation to perform the job function of export inspection of bulk vessels; and
- b. consequently, the subdelegation to that Officer of the powers and functions in Schedule 3

expires on the date shown in Schedule 1.

The Authorised Officer has agreed to the terms and conditions of authorisation, which specifies obligations regarding their performance and conduct whilst an authorised officer under the Act.
